## **Mock Trial**

#### **INTRODUCTIONS**

Assign attorney roles prior to class start time

Welcome and set the scene 05 min
Introduce mock trial participants and roles 05 min
Assign students roles (jury or testifying officer) 10 min

#### NF:

**Prior to the class start** time, assign roles to the three attorneys (judge, prosecuting attorney, and defense attorney).

**Welcome** the volunteers to the mock trial, thank them for their participation, and give them an overview of the day's agenda. See below for a sample welcome:

First off, thank you for your effort and participation in today's mock trial. We could not do this without all of you. One of the primary goals of today's mock trial is to expose recruits to the experience of testifying, as well as learn about the courtroom process through simulation. Prior to the mock trial, recruits learned about criminal investigations by investigating a "real" crime. While investigating the crime, recruits practiced creating a case file, writing reports, diagramming crime scenes, managing crime scenes, photographing crime scenes, searching and collecting evidence at crime scenes, the id process, how to obtain and issue a search warrant, what to consider when interviewing witnesses and how to prepare for testimony if they are called to trial. Today's trial is a culmination of months of hard work. The case file the attorneys received was created by portions of student's individual case files that they created over the course of the investigation. Our goal in this process was to expose the students to criminal investigations work and courtroom testimony. Once the trial is complete, the students will have an opportunity to ask the attorney's questions and the attorneys will have an opportunity to acknowledge the group's successes as well give constructive feedback.

**Assign student roles.** Draw student names out of a hat for the 12 student jury members and the 18 students that will play the interchangeable officer. NOTE: The interchangeable officer will switch every 4-5 questions while on the stand, so that all 18 students get an opportunity to take the stand. When it is time for cross-examination, rotate the officers through the stand every 4-5 questions again.

LEARNING JOURNAL: Students should observe and analyze the testimonies of themselves and their peers, as well as take notes of the mock trial process as a whole. Report their reflections in their learning journal after the trial.

NTF: Due to time constraints, the defenses' case will be truncated. Let the courtroom know how the trial would normally go, but the defenses' case will not be part of the mock trial, unless time and resources are available.
